

MORETON SHOW: GREEN CARD SCHEME
Terms and Conditions for Participating Members

These Terms and Conditions (the "Terms") set out the basis on which you can use your Green Card. Please read these Terms carefully as they contain important information. By using your Green Card you are confirming that you have read, understood and agreed to these Terms. These Terms will be available on the Moreton Show website www.moretonshow.co.uk.

1. General

1.1 These Terms apply to the Green Discount Card ("Green Card") provided to you by the Moreton-in-Marsh Agricultural and Horse Show Society ("we" or "us" or "The Moreton Show") and govern the relationship between The Moreton Show Society and Members of the Green Card scheme ("you" or "your" or "Participating Member"). The businesses participating in this Green Card Scheme ("Participating Businesses") have agreed to offer discounts to Participating Members.

1.2 The products and services to which the discounts apply, the amount of discount, and the terms, conditions and exclusions which apply to them is solely at the discretion of each individual Participating Business. Details of their discounts and conditions will be available on our website www.moretonshow.co.uk/members-benefits. We will use our best endeavours to keep this list up to date, but Participating Businesses may at their sole discretion vary their discounts and conditions from time to time without informing the Moreton Show. Participating Members should therefore check the precise details of discounts and conditions directly with the Participating Business before a purchase is made.

1.3 All transactions using the Green Cards are between the Participating Member and the Participating Business, and the Moreton Show is therefore not responsible for any aspect of the transaction or the quality of the goods or services supplied by a Participating Business.

1.4 The Moreton Show reserves the right to change these Terms from time to time. Any such changes will take effect when posted on our website and your continued use of the Green Card shall constitute your acceptance to be bound by the latest Terms.

1.5 The Moreton Show reserves the right to exclude businesses or products from the Green Card Scheme if they do not abide by, and comply with, the ethos and standards of the Moreton Show Society.

1.6 The construction, validity and performance of these Terms are governed by English law.

2. Use of Green Cards

2.1 Green Cards will be sent to Participating Members who are members who pay their subscriptions annually to the Moreton Show by Direct Debit; and to those who have paid for, or who are entitled to, Lifetime / Honorary Memberships. Participating Members' payments must be up to date when Green Discount Cards are used.

2.2 If you need to change the name on your Green Discount Card, please notify us of the changes you require by emailing secretary@moretonshow.co.uk. Please note that it is your responsibility to notify us of any changes to your details.

2.3. To obtain your discount on purchases, you must present your Green Card at the point of purchase.

2.4 If your purchase is over £100, the Participating Business may, at their discretion, phone the Moreton Show Office to check that the Green Card is being used by a current Participating Member.

3. Loss of Green Discount Cards

3.1 You should immediately report any loss, theft, fraudulent or unauthorised use of your Discount Card. We cannot be liable for the misuse of your Green Card. Please email secretary@moretonshow.co.uk to request a replacement card.

4. Contact

4.1 Participating Members must direct any queries or complaints relating to their purchases, and their terms and conditions, to the Participating Business in accordance with clauses 1.2 and 1.3 above. If you have any other queries, you can contact us by email, phone or post using the contact details above.

5. Data Protection

6.1 We reserve the right, at any time and without notice, to amend or waive any provision of these Terms from time to time; and/or terminate the Green Card Scheme; and/or decline to issue Green Cards; and/or on reasonable grounds, withdraw or cancel Green Cards. Reasonable grounds shall include (but not be limited to): any abuse or attempted abuse of the scheme; and/or any use or attempted use of a Green Card in a manner which is contrary to these Terms; and/or any reasonable suspicion of dishonesty in connection with the Green Card Scheme.
